For management of hydrilla on New Croton Reservoir, SonarOne may be applied in any depth of water to meet hydrilla control objectives. **More specifically, SonarOne may be applied in less than 2 feet of water where deemed necessary to achieve appropriate exposure to target hydrilla plants.**
